INVESTMENT OBJECTIVE & PHILOSOPHY

To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world. We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

The US reporting season for the fourth quarter of 2025 delivered a strong result, with Revenue +9% and Earnings +12% (in USD terms). Despite this, the S&P 500 underperformed the Rest of the World during the month. This underperformance is mainly ascribed to two factors:

- The particularly high level of capital expenditures the AI related hyperscalers announced for this year (an increase of over two-thirds on 2025) unnerved the market, negatively affecting these large S&P 500 constituents.
- The continual release of new products by new AI vendors, and specifically Anthropic, has caused huge fears of potential moat disruptions for many businesses and a flight out of many software and data-management related stocks.

Large sell transactions in these types of stocks were implemented during the month. It appears the proceeds from these transactions were mainly diverted to non-Tech related sectors and caused a broadening out of the market into various other sectors without particular fundamental drivers.

The largest contributors to Fund performance over the month were GE Aerospace, Linde and Safran. They all benefit from the above-mentioned broadening out theme. Further to this, both GE Aerospace and Safran continue to benefit from strong structural demand for aerospace turbines. Safran announced in February a stronger than expected set of operational results. Linde announced a stable result, with the stock reverting to above-average valuation levels in the broadening out backdrop.

The largest detractors from Fund performance were S&P Global, Alphabet and Amazon. S&P Global has a data business unit (called Market Intelligence) which some fear may be vulnerable to AI disruption. Their management has commented that over 95% of group revenue is derived from proprietary data. Alphabet announced a particularly strong set of results, confirming its Search and AI leadership. Amazon also announced stronger than expected results, with both stocks suffering from the capital expenditure uncertainties.

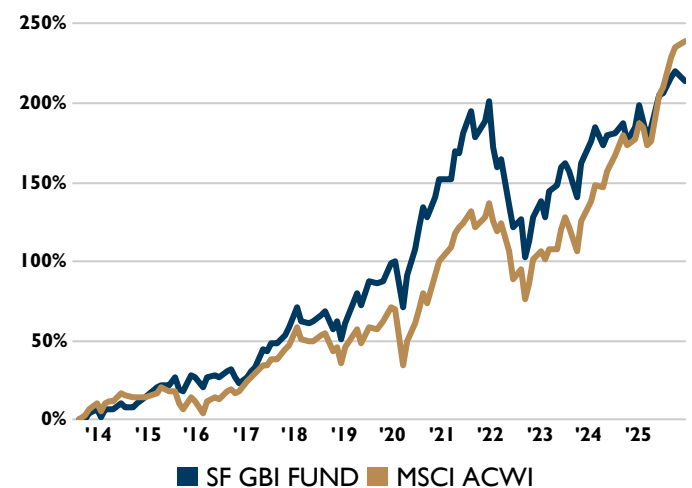

INVESTOR PROFILE
