INVESTMENT OBJECTIVE

The Fund is a feeder fund investing only in the Stonehage Fleming Global Best Ideas Equity Fund ("Master Fund"), managed by Stonehage Fleming Investment Management Limited in the United Kingdom. The Master Fund seeks to achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

The Fund has adhered to its policy objective.

INVESTMENT PHILOSOPHY

We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

Following a relatively subdued last quarter of 2025, stock markets started the new year on a positive footing. The continuing resilient US economy, its inflation under control, the continued growth in world trade (indicating economic growth in the rest of the world) and more indications of a potential de-escalation of the war in Ukraine all contributed to support investor sentiment. Further to this, a third of S&P 500 constituents have reported so far, delivering strong earnings results (revenue +7%, earnings +15%, exceeding consensus expectations) confirming a constructive business environment and rising profitability. Volatility in the commodity and crypto currency markets has more recently started to affect overall capital markets.

The largest contributors to performance over the month were ASML, Alphabet and AIA. ASML and Alphabet benefitted from the continued strong AI theme. ASML announced excellent results, growing capacity demands at their main clients, a doubling of the consensus expected orders, a 17% increase in its dividend and a €12bn share buyback. Alphabet's Gemini AI large language model is taking market share, Apple has contracted to use Gemini to drive their Siri software, and the advertising market remains strong (based on Meta's results). With solid operational performance, AIA continued its rerating process.

The largest detractors from performance were Microsoft, LVMH and Visa. Microsoft announced strong results and outlook, but the announcement of further high capital expenditures and the high 45% share that OpenAI makes up of their order book raised questions on an over dependency on this one client. LVMH's results did not fully reflect the structural turn in the US luxury market investors expected. Despite a strong set of results, Visa suffered from President Trump's support for the Credit Card Competition Act, which seeks to increase network competition in US credit for payments.

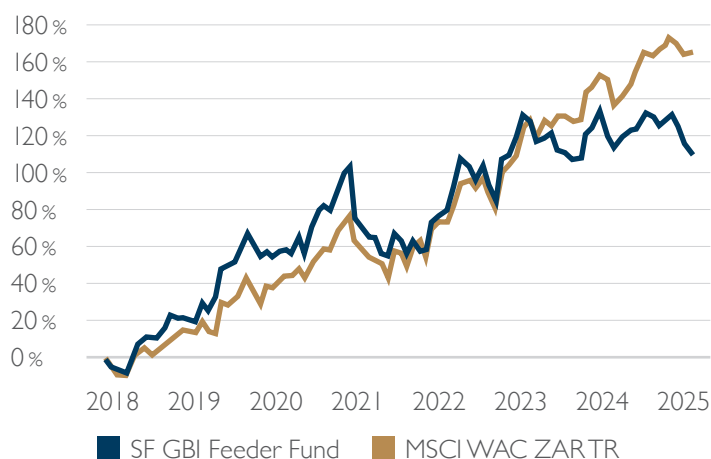
