To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world. We invest in best in class businesses for their quality, strategic competitive edge and value.

FUND COMMENTARY

World stock markets were dominated by the conflict in Iran throughout March. The more than 50% increase in the oil price fuelled global inflation and, consequently, fears of higher interest rates. This backdrop was exacerbated by the appointment of Kevin Warsh to lead the Federal Reserve (Fed), injecting a further sense of 'higher-for-longer' US interest rates. The ten-year Treasury yield increased from 3.9% to 4.3% over the month.

Stock market volatility, as measured by the VIX Index, accelerated to a reading of 31.0, which is over +2 standard deviations above average. These levels were last seen with the Liberation Day announcements in April last year, the unwinding of the Yen carry trade in 2024 and the severe Fed tightening process in 2022. All these events offered good stock market buying opportunities.

Despite the potential knock-on effects from the Iran war listed above, the global fundamental backdrop is constructive. The US economy remains resilient, with Consumption growing at +5.3%, the Services PMI rising to above average levels and Industrial Production in positive territory. Earnings revisions have kept rising, with consensus twelve month forward earnings expectations of +18% for the S&P 500 Index. The bottom-up valuation for the S&P 500 is +26%, against the historic average of +13%.

With the weak performance in March, no stocks in the Fund provided positive contributions. Netflix, West Pharma and Amazon were flat. The largest detractors from performance were GE Aerospace, Safran and ASML. The former two were negatively affected by the weak sentiment on air travel, given Dubai's exposure to the conflict and its role as a large travel hub. Alphabet's success with developing more effective chips, which could reduce demand for semiconductors, weighed on ASML.

The current S&P 500 and MSCI AC Indices provide for a large margin of error in earnings projections and consensus valuations. Barring a severe escalation in the war, we believe the risk of further potential stock market downside is smaller than the potential upside over any reasonable investment horizon.

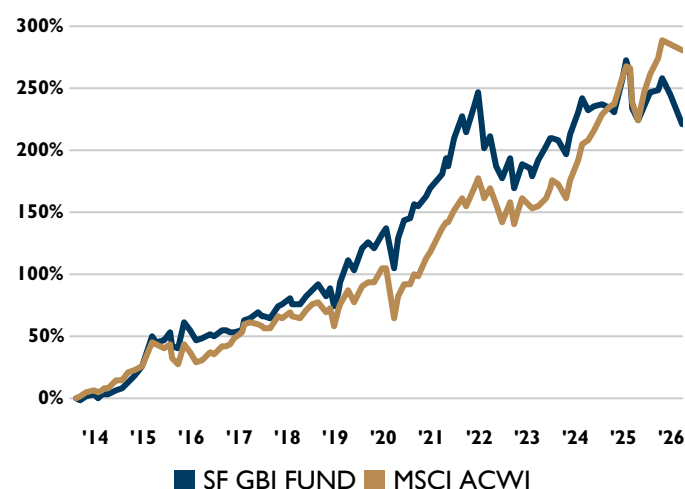

INVESTOR PROFILE
