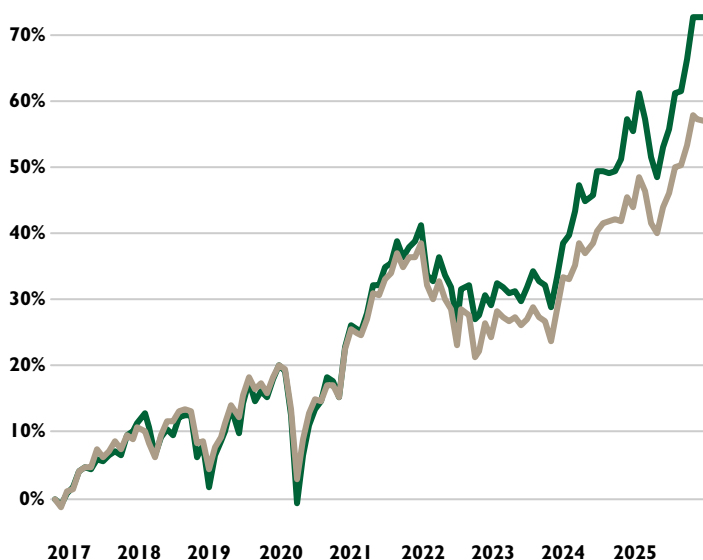

PORTFOLIO COMMENTARY

The Global Growth Portfolio returned -0.05% in December, taking 2025 returns to +11.06%.

Global economic conditions remained mixed, with GDP growth proving resilient but short-term uncertainty elevated, driven by ongoing trade frictions, shifting AI-related investment dynamics, and fiscal policy ambiguity. Monetary policy easing continued in December. The Federal Reserve delivered its third consecutive 25bps rate cut, despite a split vote reflecting ongoing concerns around inflation.

Over December, active exposure to GLG Undervalued Assets and passive exposure to the Euro Stoxx 50 index were notable positive contributors to portfolio performance. GLG Undervalued Assets benefitted from allocations to defensives and commodities, while iShares Core Euro Stoxx 50 outperformed on expectations of future Fed rate cuts, anticipated to boost inflows into European equities, alongside a rotation into cyclical sectors and financials. Gold extended its rally, finishing the year above \$4,000 per ounce and continues to be a key driver of performance. US equity markets were largely unchanged in December, with performance reflecting year-end consolidation following strong gains earlier in the year. Emerging market equities significantly outperformed US equities over December, led by robust returns in China, as well as a supportive backdrop from global rate cuts and a weaker US dollar.

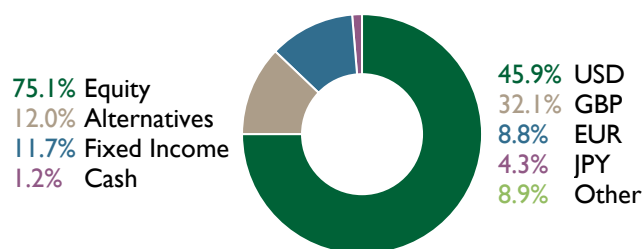

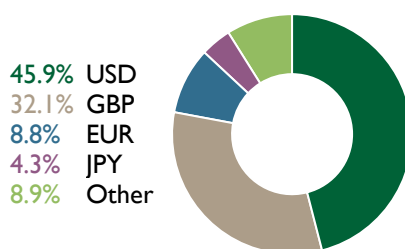

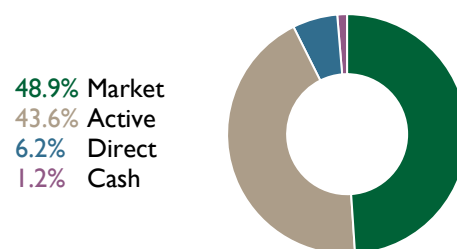
ASSET ALLOCATION
