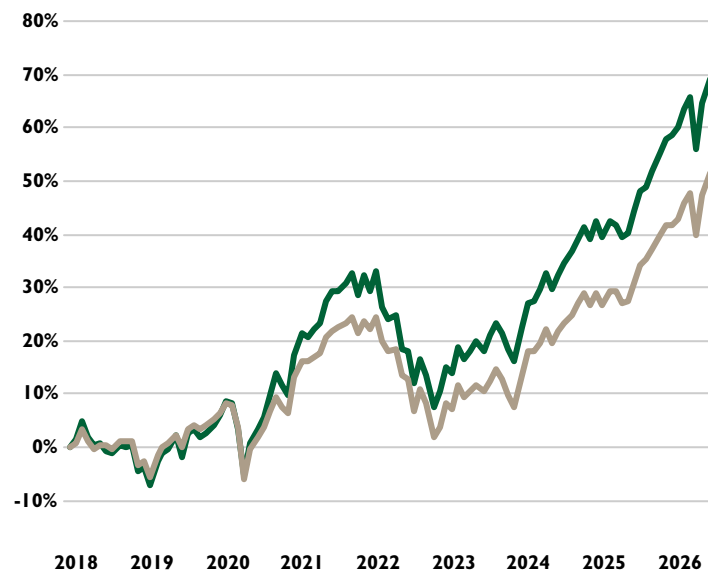

## PORTFOLIO COMMENTARY

The fund delivered a positive return in May, outperforming the benchmark. Global equities remained strong, with investors largely looking through geopolitical tensions in the Middle East. In the US, broad-based earnings supported returns, led once again by the technology sector, although sentiment within the “Magnificent Seven” became more selective amid scrutiny of heavy capital investment plans. Elsewhere, Taiwan and Korea outperformed, benefiting from AI-related demand and hyperscaler investment, while Japanese equities were supported by optimism around the new government’s expansionary policy stance. In fixed income, yields declined after rising earlier in the month, aiding bond market recovery alongside tightening credit spreads. Commodities ended the month lower, primarily weighed down by declines in energy and precious metals.

Within equities, we saw strong performance from Veritas Asia and Jupiter Global Equity Growth. Veritas continued benefited from their stock selection in AI infrastructure, particularly SK Hynix and Samsung. Meanwhile Jupiter benefited from its allocation to technology which had a strong month.

The fixed income allocation delivered positive returns in May. PIMCO Income was one of our better performers, helped by its duration exposure as well as its holdings in spread positions across corporate credit and emerging market debt. Alternatives also delivered positive returns, led by Marshall Wace, with the portfolio benefiting from their exposure to semiconductors, capital goods and banks.

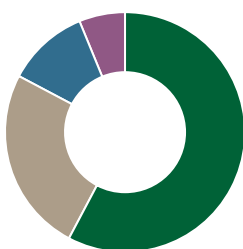

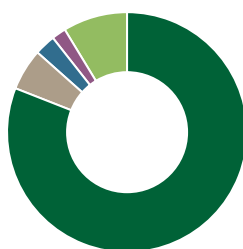

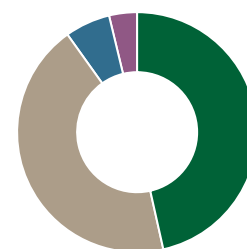
