Product

The Central Bank of Ireland is responsible for supervising Carne Global Fund Managers (Ireland) Limited in relation to this Key Information Document.

The Fund is authorised in Ireland and regulated by the Central Bank of Ireland.

The Fund is managed by Carne Global Fund Managers (Ireland) Limited (the "Manager") which is authorised in Ireland and regulated by the Central Bank of Ireland. Stonehage Fleming Investment Management Limited (the "Investment Manager") has been appointed as investment manager to the Fund.

What is this product?

Type: The Fund is domiciled in Ireland and is an open-ended investment company ("OEIC") and qualifies as an undertaking for collective investment in transferable securities ("UCITS").

Intended retail investor: The Fund is suitable for investors seeking long-term capital appreciation with an initial subscription of USD 1,000,000. In addition Share Classes may be offered to investors who are clients of the Investment Manager or its associates paying fees as agreed separately between such investors and the Investment Manager.

Term: This Fund has no maturity date.

Objectives:

The investment objective of the Fund is to achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics.

The Fund performance will be measured against the MSCI ACWI Sustainable Development Index USD Net Total Return (the "Benchmark").

The Fund is considered to be actively managed in reference to the Benchmark by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain elements of the Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

In seeking to achieve its investment objective, the Fund will invest predominantly in a range of underlying collective investment schemes (the "Underlying Funds") which comply with the Central Bank's requirements as regards investment by a UCITS in other collective investment schemes and where such Underlying Funds provide exposure to a portfolio of assets comprising mostly global equities and equity related securities (which may be listed or traded on Recognised Exchanges or unlisted) and cash.

Such Underlying Funds may also provide exposure to other elements, being bonds (including corporate debt securities and bonds issued by sovereign, supranational entities and/or corporate issuers rated investment grade at time of purchase from either Moody's or another generally recognised international rating agency), non-investment grade debt, emerging markets, and infrastructure exposure (e.g. solar and wind power generation), subject to and in accordance with the investment restrictions set out in the Prospectus.

What are the risks and what could I get in return?

Risk indicator

What happens if Carne Global Fund Managers (Ireland) Limited is unable to pay out?

The assets and liabilities of the Fund are segregated from those of the PRIIP Manufacturer. The assets of the Fund are held in safekeeping by the Depositary. In the event of the insolvency of the PRIIP Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. In the event of the insolvency of the Depositary, you may suffer financial loss. There is no compensation or guarantee scheme in place which may offset, all or any of, your loss.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact the Fund's capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Costs over time
