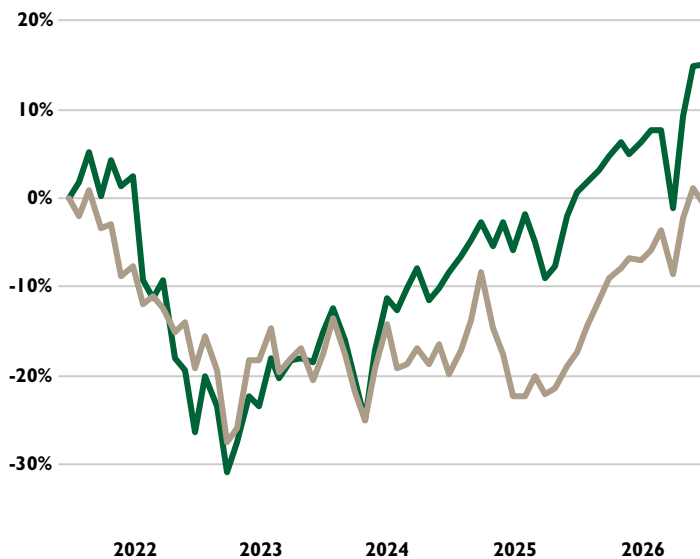

INVESTMENT OBJECTIVE

The investment objective of the Fund is to achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics.

PORTFOLIO COMMENTARY

The Fund had a strong second quarter, outperforming the benchmark, the MSCI Sustainable Development Index. Global markets rallied over the quarter driven by the de-escalation of the Middle East conflict and continued earnings growth from companies involved in the AI supply chain. Emerging Markets were notably strong over the quarter benefitting from the semi-conductor rally.

Consistent with the first quarter, our impact strategies were among the strongest contributors to performance. Lyrical Global Impact Value, Pictet Global Environmental Opportunities and Nordea Global Climate and Environment delivered particularly strong returns. Performance was supported by holdings exposed to energy efficiency and electrification trends, which continue to benefit from significant investment in AI-related infrastructure and data centre expansion. As data centre power requirements increase, demand for energy-efficient technologies remains strong. Notable examples include Renesas, whose semiconductors support electric vehicles and energy management applications, and Flex Ltd, which provides manufacturing solutions for solar power systems, grid infrastructure, and energy storage technologies.

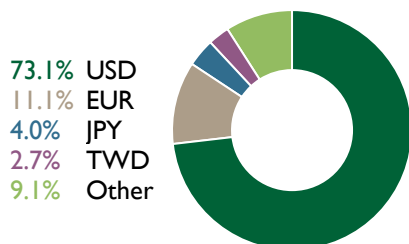

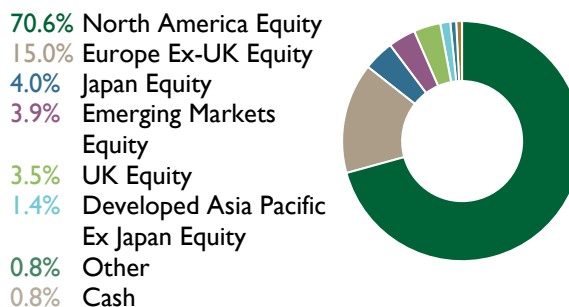

INVESTOR PROFILE
