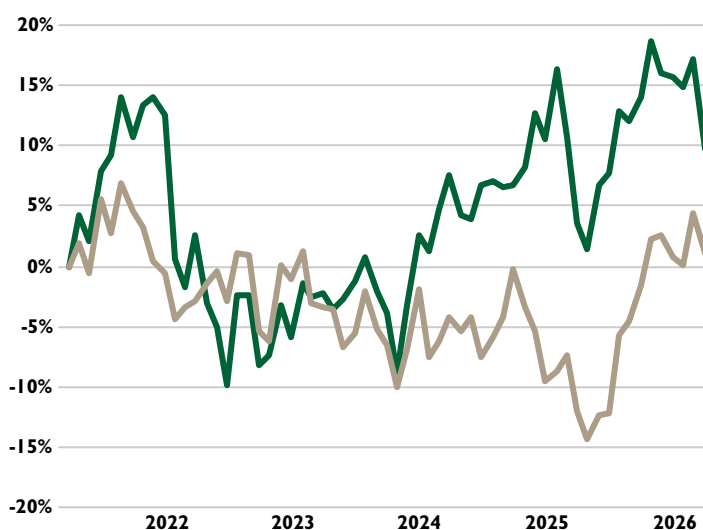

INVESTMENT OBJECTIVE

The investment objective of the Fund is to achieve capital growth over the longer term by investing in a blend of collective investment schemes which either have a sustainable investment objective or promote environmental and/or social characteristics.

PORTFOLIO COMMENTARY

The Fund posted negative returns for the first quarter as did the benchmark, the MSCI ACWI Sustainable Development Index. Global markets were unsettled by the conflict in the Middle East and the subsequent closure of the Strait of Hormuz, a critical conduit for global oil and gas supplies, which materially disrupted global trade. As a result, the quarter saw broad-based stress across financial markets.

Our impact funds, Rockefeller Climate Solutions and Nordea Global Climate & Environment, were the strongest performers over the quarter. Nordea's performance was supported by the fund's exposure to renewable energy, including holdings such as MasTec and Vestas Wind Systems. Renewable energy benefitted from the closure of the Strait of Hormuz, as it reinforced the strategic importance of domestic and secure energy supply. In addition, heightened volatility and the spike in oil and gas prices improved the relative cost competitiveness of renewables, particularly utility scale solar and wind. This theme also supported adjacent and enabling areas within the energy transition, including grid infrastructure as well as transmission and distribution assets.

Areas of the strategy that held up less well were those with a strong emphasis on high quality businesses, particularly those in industries where there are concerns about AI disruption. Fundamentals for most of these businesses are healthy, and our expectation is that resilient earnings results and guidance in the coming quarters will see a number of these companies re-rate.

1. The MSCI ACWI Sustainable Development Index (GBP Net Total Return) was introduced as a secondary benchmark on 01/05/2025. With effect from 24/03/2026, it has become the Fund's benchmark. The Investment Manager considers this index to be a more appropriate benchmark for the Fund's investment exposure.

2. The OCF is the Annual Management Fee plus additional fund expenses as a percentage of the assets of the fund. This gives an indication of annual expenses. This figure may vary over time. It excludes portfolio transaction costs.

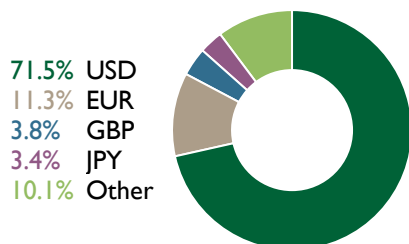

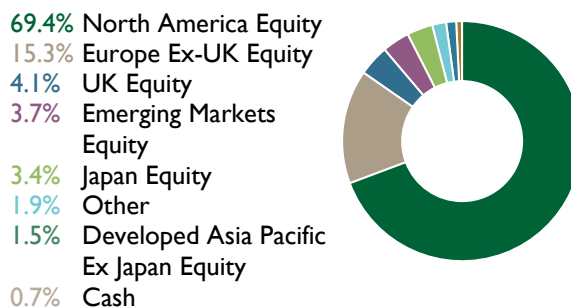

INVESTOR PROFILE
