To achieve long-term growth in capital and income in a focused portfolio of high quality listed businesses from around the world.

FUND COMMENTARY

April was the most volatile month in stock markets since the pandemic, according to the VIX volatility index. This followed the 2 April Liberation Day US tariff announcements, resulting in stock markets globally dropping sharply. Following the announcement of a 90-day tariff negotiation window and selective tariff concessions, the MSCI AC World index bottomed on 8 April and had recovered almost all of its losses by month end.

The huge tariff uncertainties, along with the haphazard way the matter is dealt with, have unnerved investor confidence and raise questions on the US exceptionalism theme, increased the US market's equity risk premium and further supported the relatively new trend of investors considering alternative investment destinations. Whilst the tariff announcement shock has caused many tactical investor reactions, we believe we are already beyond peak uncertainty and that new information on this front provides either more certainty or a better outcome than the initial announcements.

Our Fund is well positioned in this context. Around three quarters of the portfolio's weighting is in more service-orientated businesses with less tariff implications, and less than a fifth of the portfolio is in businesses with more manufacturing type of activities that may be exposed. The Fund did outperform its benchmark index over the month.

The Fund's top movers over the month were all results driven. The largest contributors to performance were Netflix, Cadence Design Systems and L'Oréal. Netflix's profitability profile is stepping up, with Cadence announcing strong double-digit top-line semiconductor related growth. L'Oréal announced stable top-line growth despite a strong € currency, outperforming many in its peer group.

The largest detractors from performance were UnitedHealth, LVMH and AJ Gallagher. UnitedHealth suffered due to a -12% cut in its 2025 outlook. LVMH struggled to grow with a -2% €-based top-line result. AJ Gallagher's main peers reported weak results.

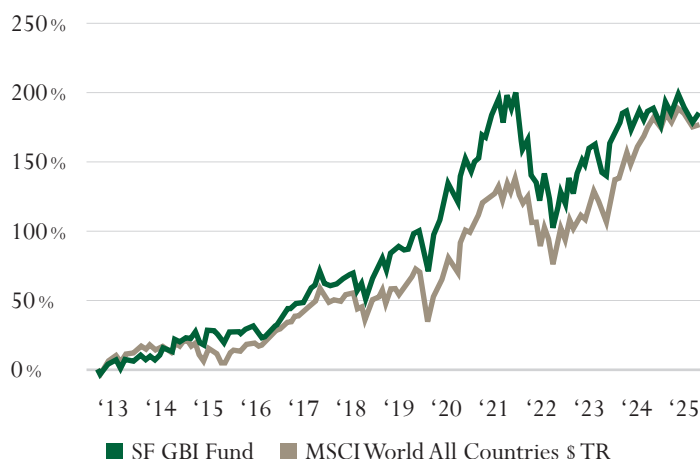

INVESTOR PROFILE

The fund is appropriate for all investor types, including those with only a basic knowledge of funds.
