**FUND COMMENTARY**

World equity markets staged a welcome recovery in January, following the extreme volatility in December. The MSCI World AC index had a positive return in all major currencies.

We listed the major reasons for the volatility in our December fact sheet. Some of the tactical reasons amongst these have now passed their one-off effects, but more importantly, it has also become clear that the fundamental economic outlook is not as uncertain as some had feared.

The Federal Reserve has made it clear that it will 'apply patience' in its tightening programme and will be 'data dependent' in its considerations. This has calmed many investors' nerves with a broader belief that the Fed may not be overly aggressive and unintentionally hurt the US economy. Fears for sharply rising interest rates have been abating, and the yield curve has stopped flattening (the long curve is actually steepening somewhat). The ISM Manufacturing PMI data in the US improved in January, with the closely watched New Orders component showing particular strength following a weaker reading in December. The continuing high US new employment data surprises many, and is reflecting in healthy consumption growth.

The strong US Dollar was a headwind to global capital markets on different fronts last year. It seems as if its strength has run most of its course, and it continued its slow process of 'rolling over' in January. On this theme, Emerging Market equities continue a new trend of outperforming developed markets and we can also expect most US businesses to benefit from a potentially weaker Dollar. This can support US company earnings growth.


It seems therefore that the US fundamental economic and business earnings outlook remain stable whilst some investors still await conclusive results from the US-Sino trade tariff negotiations.

All the Fund's holdings contributed positively to its performance in January. We have invested more in some of the existing holdings following our active investment programme in December.

The Fund is an approved Foreign Collective Investment Scheme in South Africa where it is registered with the Financial Sector Conduct Authority (South Africa). The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription,

sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
