FUND COMMENTARY

World stock markets have started the new decade off on a strong footing. Investors had history on their side with the combination of exceptionally strong years (like 2019) predominantly being followed by another positive year, US presidential election years usually delivering well and the OECD leading indicators for all the major regions currently turning for the better off their low bases. By 17 January the MSCI World AC index had already appreciated by +2.5% and the S&P 500 index by +3.1%. The subsequent disturbing news of the spread of the coronavirus which has been classified as a global emergency and resulted in over 350 related deaths by the time of printing quickly dampened this enthusiasm. The MSCI World AC and S&P 500 indices dropped -3.6% and -3.1% respectively from their individual peak levels. Both indices recorded negative January results.

Apart from the SARS virus in 2002/03 investors unfortunately have few parallels to draw for guidance of what may be expected. Whilst the current number of 14,500 coronavirus infections already exceeds the total 8,098 SARS infections, the current fatality rate of 2.2% is much lower than the 9.8% (774 deaths) in the case of SARS. It is also heartening to see the strong actions of the Chinese and other governments to prevent further spreading of the virus. It remains, though, impossible to forecast the potential overall coronavirus effects.


World capital markets at the time of the SARS incidents were at the tail end of the 2000 – 2003 technology bubble inflicted bear market and the Iraq war invasion. It is therefore not possible to assign the stock market performance at the time specifically to the SARS uncertainties. That having been said, the epidemic lasted from November 2002 to July 2003. The world stock market was volatile during that period, but recovered to its November peak within six months by May 2003 and subsequently sustained a strong recovery (+31.6% over the full year). The market offered a good buying opportunity at the time of SARS.

The Fund is an approved Foreign Collective Investment Scheme in South Africa where it is registered with the Financial Sector Conduct Authority (South Africa). The Fund has been granted consent pursuant to the Control of Borrowing (Jersey) Order 1958, by the Jersey Financial Services Commission ("JFSC") to circulate an offer for subscription,

sale or exchange of shares in Jersey. The JFSC is protected by the Control of Borrowing (Jersey) Law 1947, as amended, against liability arising from the discharge of its functions under that Law. Link Fund Administrators (Ireland) Limited has been appointed as the manager (the "Manager") of the Company and Stonehage Fleming Investment Management Limited has been appointed as the investment manager (the "Investment Manager") of the Company.
