



PORTFOLIO COMMENTARY

The Global Balanced Portfolio returned 2.3% in August, taking 2020 returns so far to -0.6%. The summer period saw continued strong gains for equities, with the US market delivering the best August return since 1986, up 7%, while the tech-heavy Nasdaq returned almost 10% for the month. We continue to allocate to this index through a low cost passive strategy, which has returned c. 37% in 2020 so far.

Central banking policy is having a profound effect on market action. The Federal Reserve outlined their tolerance of higher inflation over the past month, supporting the view that ultra-low rates are here to stay. This has pushed inflation expectations to pre-crisis levels and has coincided with a weaker US Dollar, which has also supported physical gold and broad commodity prices. We added to our physical gold position this month, taking it to c. 5%, and have seen continued recovery from the equity and credit components of the portfolio.

ACTIVE MANAGER IN FOCUS

The **Findlay Park American Fund** invests in large and mega-cap US equities, focusing on their cash flow generation and profit sustainability. Top holdings currently include Microsoft, T-Mobile and Amazon. At a sector level, the manager favours Healthcare, Communications and Financials and avoids Utilities and Real Estate. In recent months the fund has maintained an elevated cash balance reflecting the manager's cautious outlook. Over the long term the team have delivered strong outperformance of the US market and followed a disciplined process and philosophy that remains in place today.
